Conditions of Enrolment

Enrolment at this school is subject to the following terms and conditions that:

- 1. You agree to support and allow the student to share fully in the life, programmes, devotional activity and discipline policies of the school.
- You understand that the school may suspend enrolment in accordance with Board policy and Ministry of Education guidelines if attendance dues payable to Faith City Church (the Proprietors) are one term in arrears, students concerned shall cease to attend Faith City School *unless* satisfactory arrangements are made with the Proprietors.
- 3. Parents will give at least one term of notice (where possible) of termination of enrolment.
- 4. You agree that the student can leave the school for education day trips as a part of their class programme.
- 5. Students are required to be in the correct uniform at all times. Uniform items must be named and kept in good condition. Should there be the occasional situation where your child is unable to wear full, correct uniform, the teacher must be informed. PE uniform is to be worn to any outside of the classroom sporting events.
- 6. You agree to undertake to provide the child with all stationery and other equipment of a personal nature that may be required to enable the child to benefit from the education offered.
- 7. You allow the school staff to check your child for head lice (to monitor this pest when there is a problem within the school) and you agree to treat your child immediately if it is required.
- 8. You agree to keep the student home if sick. You must be prepared to retrieve a student if sick with a tummy bug. Any vomiting must have stopped for 24 hours before a student returns to school.

Blanket Consent for Education Outside the Classroom

Education Outside the Classroom (EOTC) is the name given to all events/activities that occur outside the classroom, both on and off the school site. This includes sport.

Faith City School uses a range of environments and experiences to enhance our students' learning. We have ready access to the beach, rivers, mountains and the bush in our area and beyond. These areas are rich learning environments for our students both in and out of school. Students need to learn how to be safe in certain environments. Our school also values the concept of providing students with a wide range of opportunities. Thus, some of the learning for students occur beyond the school site and Faith City School seeks your consent for your child to participate in such learning with low risk.

You will be informed of these low risk activities e.g. library visit, when they occur but will not be required to complete permission slips for these activities every time they occur.

This agreement does not cover activities such as school camps or activities. Where activities are deemed as medium to higher risk activities your consent will be required. These will be fully communicated and permission from you will be required.
