Thank you for taking the time to complete the following form for the prospective Parent/Guardian who is applying to enrol their child/ren at Faith City School.

Background Overview About Faith City School and Preferential Status for Pre-Enrolments

Faith City School provides a Christ-centred education promoting excellence and equipping students with a Christian worldview as a basis for continued learning. The school is a mission of Faith City Church and is situated on the church property at 127 Springvale Road, Whanganui. The school has a maximum roll of 150 students and currently consists of six classrooms. Faith City School is a full primary school, teaching students from Year 1-8. As the school is a Christ-centred school the school's Enrolment Policy gives preference to children of Christian parents.

Faith City School's Enrolment Policy (NAG 6) States

- 1.5 Preferential enrolments will be granted to the children of Christian parents, who desire to see their children educated in a biblical and God honouring way.
- 1.6 Non preferential enrolments will be granted to children of non-Christian parents but shall not exceed 5% of the school roll.
- 1.7 All other criteria being equal, priority will be granted to 5 year old enrolments and to transferees from other Christian schools.

Priority status for enrolment to Faith City School is as follows:

- 2.21 Preferential siblings i.e. children of Christian parents who already have children at the school.
- 2.22 Preferential new enrolments i.e. Faith City Church new enrolments have priority over preferential new enrolments if applied for at the same time – see Deed.
- 2.23 Non preferential siblings (see also clause 1.6)
- 2.24 Non preferential new enrolments.

(NB: A full copy of Faith City School's Enrolment Policy can be requested if required).

Reference Requested

In support of Preferential Enrolment Status Parents/Caregivers or Guardians are asked to supply the school with <u>a reference</u> from the Minister or an Elder of the church that they attend. By supplying a written reference to the school from a Minister or Elder it assists with confirmation that their child/ren genuinely meet the Preferential Status in the School's Guidelines.

Action Required

You have been given this reference from a prospective Parent/Caregiver or Guardian to complete as supporting evidence of their Preferential Status while Pre-Enrolling their child/children to Faith City School. It would be much appreciated if you are able to complete the form on their behalf in a timely manner to assist with their Pre-Enrolment application.
